A vote in a primary election is void if the voter previously voted in a primary election of another party or participated in a convention of another party during the same voting year." A person who participates in a convention or primary election of a party other than the Republican Party during the same voting year is disqualified from participation as a delegate, alternate, party officer, or nominee of the Republican Party at any level during the voting year.
